Important Announcement Regarding Applying for School Lunch & Fee

1. School Lunch Fee Payment Change to Public Accounting

From April 2024, Sakai City will change the handling of school lunch fees from "private accounting," in which payment is collected and managed by each school, to "public accounting," in which payment will be handled by the city. As a result, payment of these fees will change from the schools to Sakai City.

For the 2023 school year, there will be no changes to the current payment procedures.

2. Submission of "School Lunch Application Form," "Direct Debit Request Form," and "Copy of Bankbook"

With the change to public accounting, parents/guardians will be required to submit the enclosed "School Lunch Application Form", "Direct Debit Request Form" to withdraw school lunch expenses from an account, and a "Copy of Bankbook" of the financial institution account designated for payment.

Therefore, <u>please fill out the enclosed "School Lunch Application Form" and "Direct Debit Request</u> <u>Form", attach a copy of your bankbook, place them in the return envelope enclosed and submit them</u> <u>by the deadline.</u>

Once complete, they do not need to be submitted again when entering or transferring to any other Sakai City Schools (elementary school, junior high school, or special needs school).

(1) School Lunch Application Form Used to apply for school lunches

Please fill out the required information referring to the example on the last page. One copy of this application form must be submitted per student.

This application can also be processed through the online application system. If you wish to apply online, please access the following URL or QR code to complete the application process online.

Please note that the enclosed "School Lunch Application Form" is not required if applying online. *However, the "Direct Debit Request Form" and a bankbook copy must still be submitted.

(2) "Direct Debit Request Form" Accounts currently registered with schools must still be submitted.

This form produces multiple carbon copies. Without tearing off the first sheet, fill in your details per the example shown.

One copy of this form can be used for up to three students.

When submitting, please keep the first page (cover page) and the fourth page for your records and submit the second page and third page.

*In general, school lunch expenses must be paid via direct debit.




(3) "Copy of Bankbook"

Please submit a copy of the bankbook of the account designated on the "Direct Debit Request Form." *Please take a copy of the page with the account information, such as the account number and account holder name.

*If you do not have a bankbook, please submit a copy of a screenshot or cash card that confirms the name of the financial institution, branch, account number, and account holder.

3. School Lunch Fee

The school lunch fee and direct debit dates (payment due dates) for the 2024 school year are scheduled as follows (9 times a year).

This amount is the current estimate. The fee amount may change in the future.

- The school lunch fee is ultimately paid based on the number of times it's served during the year. The last school lunch payment will be decided during the final period.
- If the direct debit date falls on a Saturday, Sunday or holiday, the withdrawal will be carried out on the following business day of the designated financial institution.
- If the direct debit cannot be made due to insufficient balance or other reasons on the designated payment date, the withdrawal will be attempted again on the 10th of the following month (or the next business day if it is a Saturday, Sunday or holiday).

*There may be some months when it will not be possible to reschedule withdrawals.

- The annual payment amount and the payment amount for each term will be notified around July of each year.
- If you wish to stop receiving all or part of a school lunch due to a food allergy or other reason, please consult with the student's school.
- If opting out of milk or bread due to food allergies, the fee amount may be reduced.

School Lunch Fee Payment Procedures Q&A

Q1 What happens if I fail to complete the "Direct Debit Request Form "by the deadline?

A1 If the procedure is not completed, direct debit may not be available for the first school lunch fee. In this case, <u>please pay at a financial institution or convenience store</u> using the payment slip issued by Sakai City. Please note that you cannot make a combined direct debit on the second payment due date.

Q2 What is required to opt out of milk or bread due to food allergy, etc.?

A2 <u>The "Food Allergy Accommodation Form"(*Tabemono Arerugi Taiou Iraisho* 食物アレルギー対応依頼書) and <u>"School Life Management Guidance Form" (*Gakkoseikatsu Kanri Shidohyo* 学校生活管理指導表) must be <u>submitted to the school by the date specified by each school.</u> Please consult the school for details. After this is completed, the city must be notified to opt out of milk or bread.</u></u>

Q3 What about if you are receiving public assistance (Seikatsu Hogo 生活保護) or schooling assistance (Shugaku Enjyo 就学援助)?

A3 Even if you are receiving assistance for school lunch fees from either of the above, you must still register for an account to be used for any refunds for school lunch expenses, etc.

You must still submit the "School Lunch Application Form", "Direct Debit Request Form", and a copy of your bankbook. Thank you for your understanding.

Q4 How do I fill out the "Direct Debit Request Form" when using Japan Post Bank?
